The Government of India has partially modified the earlier monthly allocation of foodgrains under NFSA to J&K vide above referred communication. Accordingly the undersigned is directed to convey the authorization of monthly allocation of foodgrains for AAY, Priority Households (PHH) and Non-Priority Households (NPHH-Tide over) from December, 2016 to March, 2017 under NFSA as per details given below:

The above allocation is subject to the following conditions:

1. The validity period for deposit of cost and lifting of the above revised allocation under NFSA for the Month of December, 2016 will be 30 days from the date of issue of Govt. of India letter Dated: 30.11.2016. The validity period

for the rest of the months will be as per the existing instructions conveyed by the Govt. of India vide letter No.1-2/2007-BP.III dated:-11.07.2014. Further, any quantity of foodgrains already lifted in excess of the above revised allocation will be adjusted against the allocation of subsequent months.

2. The allocated quantities of foodgrains (Rice/Wheat) are to be lifted in full within the stipulated time ensuring that the ration amongst the Districts is distributed/ supplied as per the approved scale under the Targeted Public Distribution system without any re-appropriation/diversification.

3. The wheat:Rice ratio under the above-mentioned tide over allocation is one time measure for this financial year only, which would be reviewed for the next financial year i.e. w.e.f. April, 2017 and the ration may be restored to earlier level, if required. This one time measure/allocation should not be construed as change in wheat rice policy of the Government.

4. The monthly lifting/off-take statements as per prescribed format under NFSA shall be sent to the Administrative Department regularly without fail, besides furnishing of utilization certificates as per prescribed format of Govt. of India.
