The sanction/approval for allocation of foodgrains (Rice) at BPL rates under Annapurna Scheme for first six months of the financial year 2015-16 is subject to the following conditions:

- 1. The validity period for depositing the cost and lifting of allocated foodgrains will be up to 50 days from the date of issuing of allocation letter (i.e. 1st October 2015) by Ministry of Rural Development Govt. of India.
- 2. It should be ensured that there is no AAY/BPL beneficiary covered under the scheme. The beneficiaries identified under the scheme (Continued on page 2)

Annapurna be covered only. It may also be ensured that if there are any double counting error, i.e. Annapurna beneficiary also issued the AAY card on individual basis, such duplication should be removed.

- 3. The foodgrains allocated under Annapurna Scheme should be utilized only for the purpose for which the same has been allocated and not for any other purpose/scheme strictly in accordance with the guidelines of the scheme. The monitoring and implementation of the distribution of subsidized food grains under the scheme/ programme will be the responsibility of the Directorate of CA&PD Jammu/Kashmir. The food grains under the scheme must be distributed through Fair Price shops.
- 4. FCI will issue rice to the nominees of the CAPD Department of the state Govt. as per district wise sub allocation to be made by the Directorate concerned on pre-payment of the cost of food grains at BPL price from its nearest godowns/depots.
- Further Allocation of food grains under the scheme will be considered only after receipt of Utilization Certificates on prescribed formats from the respective Directorate of CAPD in respect of food grains allocated vide this sanction letter.
