**Subject**: Allocation of PDS SKO Quota of Whole Sale Dealers for the month of July, 2016.

Ref: Ministry of Petroleum and Natural Gas Govt. of India and Petroleum Planning& Analysis Cell, (Ministry of Petroleum & Natural Gas Govt. of India) New Delhi's reference Nos.P-21016/22/2015-Dist dated:- 24.06.2016 and P-4192/SKO Dated:-24.06.2016.

Sir,

You are aware that some wholesale dealers of SKO have by virtue of OWP No.91/2015 titled M/s:Behari Lal Somnath & ors V/s: State & ors approached before the Court of Law for the allocation of the Kerosene oil in terms of guidelines/policies issued vide interim office memo No.4062/Alloc dated:-05.08.1986 r/w directions of the Hon'ble High Court passed in LPA (W) Nos 504-A/98 522-A/99,562/99,498/98 titled M/s:Behari Lal Somnath & ors V/s: State & ors.The Honorable High Court Vide interim Order dated:-30.01.2015 passed in OWP No.91/2015 titled M/s:Behari Lal Somnath & ors V/s: State & ors the operative part whereof reads as under.

"Meanwhile, as ad-interim, subject to objections, respondents are directed to strictly maintain the scheme of allotment as envisaged under the guidelines (Supra), which interalia contemplate allocation of SKO to the level of 250 Kilolitres per month to High Volume Dealers in the first instance followed by the allocation to the level of 75 Kilolitres per month to the Low Volume Dealers and so on."

The department has apprised the Court of law, that there is no any classification of High Volume Dealers and Low Volume Dealers provided in the guidelines/policy in vogue and the petitioner by sheer misrepresentation and suppression of material facts from Court of law has succeeded to get the interim order. Further, the Department has also filed a CMP/Application for the modification of the above said Interim Order of the Hon'ble High Court with the





appraisal that the Department cannot allocate PDS SKO to the wholesale dealers in contravention of the Guidelines in Vogue.

The department is allocating PDS SKO as per guidelines/policy in vogue issued by the Ministry of Petroleum and Natural Gas Government of India vide Communication no: P-21016/20/2012-Dist dated 23.10.2013 by virtue of which a uniform method for allocation of PDS kerosene was adopted across the Country. Since the guidelines/policy in vogue issued by the Union Ministry are statutory in character and the department cannot bypass/ignore/violate it, unless and until the same are modified or altered by the concerned Union Ministry.

Keeping in view the above said circumstances/facts, the PDS quota to the wholesale dealers/Districts of both the divisions of Jammu/Kashmir (excluding Ladakh region) has been fixed to the extent of 4588 KLs for the month of July 2016 as per <a href="mailto:america">annexures "A","B","C", & "D"</a> of this communication as per the policy/guidelines of Government of India in vogue and subject to the final outcome of the Court Litigation.

#### The allocation of PDS - SKO shall be subject to the following conditions:

- The quota of PDS SKO is only for distribution under PDS distribution system to the targeted beneficiaries (ration card holders) and shall be used only for the purpose of cooking and illumination and not for adulteration of petrol/diesel or for any other use.
- 2. The un-lifted quota of a dealer for any particular month shall have bearing on the ensuing month's quota and quantum of un-lifted quota of preceding month by the dealer shall be deducted from his next month's Quota of SKO.
- 3. Both the Directors of CA&PD, Jammu/Kashmir may also send their compliance to Administrative Department **through fax** along with the certificate that there is no complaint of any malpractice against any whole sale dealer in the previous month, before making further district wise allocation.
- 4. The Directors of CA&PD Department, Jammu/ Kashmir shall ensure that the last month's district wise allocated quota to whole sale dealers has been reached at the proper destination and the concerned Assistant Director had certified that the K.Oil had been properly distributed among the ration card holders in the district and there is no complaint against distribution of SKO.
- 5. All the concerned Assistant Directors CAPD shall ensure that the SKO is distributed among the bonafide families and there is no complaint against the wholesale dealers in distribution of PDS SKO in the District.
- 6. The Director of CA&PD Jammu/Kashmir will also ensure that Assistant Director concerned takes the certificate from each PDS-SKO dealer issued by the PRI of the area before issuing the next month's quota.





- 7. The Director of CA&PD Jammu/Kashmir will furnish the dealer-wise/company-wise, upliftment/distribution achievement by the end of this month positively in any way.
- 8. The Director, CA&PD Jammu/Kashmir may strictly enforce the instructions issued vide this department's letter No. CAPD/Plan/SKO/01/2011-12 dated 6-12-2013 so far as allocation of PDS-SKO quota to Cooperative Kerosene dealers is concerned and not to associate the Co-operative Department in the process.
