GOVERNMENT ORDER NO: 51 - JK(FCS&CA) of 2021 DATED: 09 -06 -2021

Sanction is hereby accorded to the allocation of **4740.130 KLs** ( **Four thousand seven hundred forty point one hundred thirty KLs only**) PDS-SKO for the Districts as indicated against each, for the months of May, June, 2021 in favour of Director(s) of Department of FCS&CA, Jammu/Kashmir as per Annexure-"A" to this Government Order subject to the following conditions:-

- The Director(s), FCS&CA Jammu/Kashmir shall further allocate the SKO-PDS in favour of the bonafide stockists/agencies having the requisite licence as per the provisions contained in the SRO 285 of 2016 dated 02-09-2016 and other norms in vogue, strictly read with Order dated 03-06-2021 of Hon'ble High Court of Jammu and Kashmir passed in case titled Jehlum Oil Agency & Ors Vs Union of India & Ors. and on the Advisory issued by the Department;
- 2. The Director(s), FCS&CA Jammu/Kashmir shall take utmost measures to monitor the movement of SKO from source down to the level of actual beneficiaries and strictly adhere to the guidelines / norms issued from time to time on the subject;
- 3. The Director(s), FCS&CA Jammu/Kashmir shall ensure that the said quota is released immediately after receipt of Government Order and shall be distributed to the entitled beneficiaries strictly as per the provisions of SRO 285 of 2016 dated 02.09.2016 and other instructions conveyed by the Government from time to time;
- 4. The Directors shall ensure that the full quota of SKO for the months are utilized/ lifted well in time.
- 5. That the wholesale Dealers shall be allowed to lift their allocated SKO quota of May upto 20<sup>th</sup> of June, 2021 and that of June upto 31<sup>st</sup> June. The Director, FCS&CA Jammu / Kashmir shall furnish the lifting status to the Administrative Department.

- 6. The Utilization Certificates and lifting status shall be furnished by or before 5<sup>th</sup> of July, 2021 positively alongwith compliance reports to Administrative Department through fax. It shall also be certified that there are no complaints of any malpractice received against any dealer during the period while distributing the SKO to the entitled beneficiaries;
- 7. The allocated district-wise quota shall not be diverted to any other District without prior approval of the Administrative Department;
- 8. The Director, FCS&CA Jammu/Kashmir shall ensure that Assistant Director(s) concerned shall obtain the certificate from the elected representatives (PRI/ULB) to the effect that SKO distribution has been released to the targeted beneficiaries, as the case may be.
- 9. The Director, FCS&CA Jammu/Kashmir may strictly enforce the instructions issued vide this department's letter No. CAPD/Plan/SKO/01/2011-12 dated 06.12.2013 so far as allocation of PDS-SKO quota to Cooperative Kerosene Dealers is concerned and not to associate the Deputy Registrars of Co-operatives Department in the process. The Assistant Directors of FCS&CA Department shall allocate the quota of SKO to the Cooperative Kerosene Dealers, keeping in view the number of ration tickets attached to them;
- 10. The Director, FCS&CA Kashmir shall obtain a certificate from Assistant Director(s) that all the payments by retailers to the Wholesale SKO dealers are made by Account Payees Cheque or NEFT transfers; and
- 11.Concerned Assistant Directors may ensure that the wholesale dealers shall decant the SKO at the decanting points as notified /fixed by the Department and violation to these directions shall attract action as warranted under Rules, to be initiated by the concerned Assistant Director, FCS&CA.
- 12. The instructions issued vide letter No. FCS&CA/PDS-SKO/ACB/2020-21 dated 29.03.2021 by the Administrative Department shall strictly be implemented in letter and spirit.

Sanction is hereby also accorded to the utilization of stranded quantity of 183.658 KLs of SKO pending with Director, FCS&CA Kashmir/Assistant Director(s) as indicated by the Director, FCS&CA, Kashmir vide letter No. No.DFCS&CAK/S/K.oil/2021/228 dated 05-06-2021. Further in view of constraints of available quota the allocation in respect of Director of Food, Civil Supplies & Consumer Affairs, Kashmir has been made @ 2.75Ltrs per RC.
