Consequent upon the above and in continuation to Government Order No. 78-JK(FCS&CA) of 2021 dated 21.10.2021, Government Order No. 87-JK(FCS&CA) of 2021 dated 23.10.2021, Government Order No. 19-JK(FCS&CA) of 2022 dated 23.02.2022, Government Order No. 31-JK(FCS&CA) of 2022 dated 22.03.2022, Government Order No. 74-JK(FCS&CA) of 2022 dated 25.07.2022 and Government Order No. 99-JK(FCS&CA) of 2022 dated 13.10.2022 sanction is hereby accorded to the temporary appointment of 01 (One) more candidates (forming Annexure-I to this order), figuring in the same selection list, as MTS, (District Cadre, Kupwara) in the Department of Food, Civil Supplies & Consumer Affairs, Kashmir, in the Pay Level (SL-1) (Rs.14800-47100) with immediate effect.

- C) If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- D) If the candidate fails to join within a period of 21(twenty one) days from the date of issuance of this appointment order, he/she shall forego his/her right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department.
- E) The appointment shall be cancelled ab-initio, if it is found that the candidate(s) is having higher qualification than the prescribed one at any stage and he/she also be liable for action under law.

F) The appointee(s) shall be on probation for a period of 02 years.
