The honorarium in favour of the DPMU's from April, 2022, onwards shall be released by Director Finance, Department of FCS&CA only on receipt of the said affidavit and monthly satisfactory work and conduct reports received from the Assistant Director(s) concerned, countersigned by the respective Director, FCS&CA.

5. The DPMUs can be deployed to a district other than above, whenever required by the Administrative Department or on the recommendation of concerned Director, FCS&CA.

It is further ordered that Ms. Muneesha Kumari, DPMU, Jammu, shall work in the Department of FCS&CA, Civil Secretariat, Jammu for two days in a week under the supervision of Deputy Director, P&S, till further orders.
