Whereas, the General Administration Department vide communication No. GAD/MTGORB-IV/63/2021-09-GAD dated 18.10.2021 forwarded the recommendations/selection list issued by the J&K Services Selection Board vide communication No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 in respect of 490 (four hundred ninety) Class-IV posts pertaining to Department of Food, Civil Supplies & Consumer Affairs viz (47 Divisional Cadre, Jammu and 443 District Cadre, Kashmir) for appointment under the provisions of the J&K Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O 184 of 2020 dated 04.06.2020; and

2. Whereas, the General Administration Department had forwarded the selection list of the candidates to the respective Deputy Commissioners with the request to ensure the filling of their character verification rolls and forward the same to the Director General, CID, J&K, Srinagar for verification of Character and Antecedents of the candidates. The General Administration Department, subsequently, requested all the Deputy Commissioners to forward the verification report in respect of Character and Antecedents of all the selected candidates as received from the Criminal Investigating Department (CID) J&K, directly to the appointing authorities so that the appointment orders of these candidates are issued; and



3. Whereas, the Department has now received security verification from the Criminal Investigation Department(CID), Srinagar with regard to Character and Antecedents of (01) more candidate selected in the same selection list for the post of Class-IV, (District Cadre, Baramulla) through Deputy Commissioner, Baramulla vide No. DCB/Arms/2022/372 dated 13.05.2022; and

4. Consequent upon the above and in continuation to Government Order No. 80-JK(FCS&CA) of 2021 dated 22.10.2021, Government Order No. 86-JK(FCS&CA) of 2021 dated 23.10.2021, Government Order No. 104-JK(FCS&CA) of 2021 dated 17.12.2021, Government Order No. 01 JK(FCS&CA) of 2022 dated 06.01.2022, Government Order No. 29 JK(FCS&CA) of 2022 dated 17.03.2022, Government Order No. 38-JK(FCS&CA) of 2022 dated 07.04.2022 and Government Order No.45-JK(FCS&CA) of 2022 dated 26.04.2022, sanction is hereby accorded to the temporary appointment of 01 (one) more candidate (forming Annexure-I to this order), figuring in the same selection list, as Class-IV, (District Cadre, Baramulla) in the Department of Food, Civil Supplies & Consumer Affairs, Kashmir, in the Pay Level (SL-1) (Rs.14800-47100) with immediate effect.

5. The appointment of the candidates is subject to fulfillment of the following conditions:-

A) The appointee(s) shall report to the Director, Department of Food, Civil Supplies & Consumer Affairs, Kashmir within a period of 21 days from the date of issuance of this order.

B) The appointee(s) shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-

1. Academic/Technical Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate issued by Chief Medical Officer.
4. Domicile Certificate issued by the Competent Authority.
5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
6. Reserved Category Certificate (in case of candidates belonging to reserved category).



- C) If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- D) If the candidate fails to join within a period of 21(twenty one) days from the date of issuance of this appointment order, he/she shall forego his/her right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department.
- E) The appointment of the said candidates shall be governed by the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020.
- F) The appointment shall be cancelled ab-initio, if it is found that the candidate(s) is having higher qualification than the prescribed one at any stage and he/she also be liable for action under law.
- G) The appointee(s) shall be on probation for a period of 02 years.
- H) The inter-se-seniority of the appointee shall be separately determined by the Director, Food, Civil Supplies & Consumer Affairs, Kashmir strictly as per the applicable rules.
- I) The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- J) The appointment is subject to the outcome of any writ petition(s) pending before any Court of competent Jurisdiction .
- K) In view of the provisional security clearance received from the CID, the appointee(s) shall give an undertaking in the prescribed format forming Annexure-II to this order and in the event of any adverse report received from the CID, subsequently, the appointment of the appointee(s) shall be deemed to have been cancelled ab-initio.
