Sanction is hereby accorded to the release of Rs.16,56,83,333.00 (Rupees Sixteen Crore, Fifty Six Lakh Eighty Three Thousand Three Hundred Thirty Three only) as corresponding 25% UT share of Central share @Rs.4970.50 lakh released by GoI in favour of Director Finance Department of FCS&CA J&K i.e. Single Nodal Agency for Centrally Sponsored Scheme 4048-Assistance to State agencies towards intra-State movement of foodgrains, FPS Dealers margin and FPS Dealers additional margin under NFSA, 2013 for the year 2023-24 as per Annexure-"A" appended to this Government Order.

The Director Finance shall draw the funds and credit the same in the official Bank Account of Single Nodal Agency bearing A/C No.0110040510000162 maintained at J&K Bank, Moving Branch Civil Secretariat Jammu for further release/reimbursement to the implementing agencies through PFMS as per fixed component-wise limits against the expenditure already incurred out of Revolving Fund (Foodgrains) Account.

However, the release and subsequent utilization of the funds is subject to the following terms and conditions:-

- 1. The funds shall be utilized strictly in accordance with the NFSA, 2013
- 2. The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formally.

- 3. The amount shall be kept in SNA Account and drawn through PFMS by the implementing agencies strictly as per laid down component-wise limits for further release/recoupment of expenditure already made.
- 4. The Implementing Agencies shall furnish UC in respect of funds released at an early date in the prescribed Performa.
- 5. The expenditure shall commensurate with the physical progress achieved.
- 6. All codal formalities in consonance with GFR shall be full filled before incurring the expenditure.
- 7. The expenditure shall be closely monitored and incurred only on such items which are approved under the scheme.
