WHEREAS, the General Administration Department vide communication No. GAD/MTG0RBIV/267/2022-09-GAD dated 27.10.2022 forwarded the recommendations/selection list issued by the J&K Services vide communication No. SSB/Secy/Sel/Class-Selection Board IV/2021/6273-78 dated 18.10.2022 which also included selections for 379 (three hundred seventy nine) Class-IV posts pertaining to Department of Food, Civil Supplies & Consumer Affairs viz (01 Divisional Cadre, Jammu and 378 District Cadre) for appointment under the provisions of the J&K Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O 184 of 2020 dated 04.06.2020 & the appointment orders in respect of eligible candidates were issued from time to time;

- 2. **AND WHEREAS**, the JKSSB had kept (09) posts of MTS for Department of Food, Civil Supplies and Consumer Affairs un-filled in Phase-II on the directions of the Hon'ble Court;
- 3. **AND WHEREAS**, the GAD vide OM dated 26.09.2023 has forwarded the select list of (07) candidates only selected as Multi-Tasking Staff in the Department of FCS&CA under HCH category issued by JKSSB vide No. JKSSB/55/2022-05 (7048574) Dated 28.07.2023;
- 4. **AND WHEREAS**, as per the instruction of General Administration Department issued vide No. GAD/MTG0RBIV/01/2023 (E-7098912) Dated 26.09.2023 regarding Verification of Character and Antecedents in favour of the selected candidates were sought from the concerned quarters vide this department's letter dated 10.10.2023.
- 5. **AND WHEREAS**, the Department has received verification from the Criminal Investigation Department(CID) J&K, with regard to Character and Antecedents of (01) candidate selected in the select list for the post of Multi-Tasking Staff (Class-IV), domicile district Kupwara allotted district




Baramulla through Deputy Commissioner, Kupwara vide communication as mentioned in the reference ; and

Consequent upon the above, sanction is hereby accorded to the temporary appointment of one (01) candidate (forming Annexure-I to this order), figuring in the select list, as Multi-Tasking Staff (Class-IV) in District Cadre, Baramulla in the Department of Food, Civil Supplies & Consumer Affairs, Kashmir, in the Pay Level (SL-1) (Rs.14800-47100) with immediate effect.

The appointment of the above candidate(s) is subject to the following conditions:

- A) The appointee(s) shall report to the Director, Department of Food, Civil Supplies & Consumer Affairs, Kashmir within a period of 21 days from the date of issuance of this order.
- B) The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:
 - Academic/Qualification Certificates.
 - ii. Matriculation/Date of Birth Certificate.
 - iii. Health Certificate from the concerned Chief Medical Officer of the District.
 - iv. Domicile Certificate issued by the Competent Authority.
 - v. Valid relevant Category Certificate, if any applicable.
- C) The appointment of the above candidates shall further be subject to the following conditions:
 - a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.
 - b. Each appointee shall furnish an Undertaking in the shape of an Affidavit as per Annexure-II to this Order;
 - c. The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agency.
 - d. The appointee shall be on probation for a period of two years.
 - e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
 - f. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the



District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

g. The inter-se-seniority of the appointee in the J&K Food, Civil Supplies and Consumer Affairs (Subordinate) Service shall be determined as per the J&K Civil Services (Classification,

Control and Appeal) Rules, 1956.

h. The appointment of the above appointee shall be cancelled ab-initio, if it is found that they possess higher qualification than the prescribed one at any stage and he/she shall also be liable for criminal prosecution under law.

i. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent

Court of law.

j. If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment

shall be deemed to have been cancelled ab-initio.

k. If the candidate fails to join within a period of 21(twenty one) days from the date of issuance of this appointment order, he/she shall forego his/her right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department.

I. The Cadres allocated by the appointing authority/JKSSB shall not be changed under any circumstances by any Authority/Department.
