Sanction is hereby accorded to the release/recoupment of Rs.67,80,46,333.00 (Rupees Sixty Seven Crore Eighty lakh Forty Six Thousand Three Hundred and Thirty Three only) as part of advance Central/UT share in favour of Director, FCS&CA Jammu/Kashmir through PFMS from Single Nodal Agency Account for Centrally Sponsored Scheme 4048-Assistance to State agencies for intra-State movement of foodgrains, FPS Dealers margin and FPS Dealers additional margin under NFSA, 2013 for the FY 2022-23 and 2023-24 as per annexure "A" & "B" appended to this Government Order.

Both the Directors shall draw the funds strictly as per the component-wise limit set in Annexure "A" & "B" by debiting the official Bank Account of Single Nodal Agency bearing A/C No.0110040510000162 maintained at J&K Bank, Moving Branch Civil Secretariat Jammu through PFMS for recoupment, wherever expenditure has already been made out of Revolving Fund (Foodgrains) Account or further releases to implementing agencies through PFMS.

However, the release and recoupment of the funds is subject to the following terms and conditions:-

1. The funds shall be/have been utilized strictly in accordance with the NFSA, 2013 guidelines and for the purpose for which it has been sanctioned/released.
2. The release of funds does not confer the sanction to incur the expenditure which should be/has been booked only after observing all codal formalities.
3. The amount shall be kept in SNA Account and drawn through PFMS by the implementing agencies strictly as per laid down component-wise limits for further release/recoupment of expenditure already made, as per norms.
4. The Implementing Agencies shall furnish UC in respect of funds released at an early date in the prescribed Performa.
5. The expenditure shall commensurate with the physical progress achieved.
6. All codal formalities in consonance with GFR shall be/should have been full filled before incurring the expenditure.
7. The expenditure shall be closely monitored and incurred only on such items which are approved under the scheme.
