Department vide the General Administration WHEREAS. communication No. GAD/MTG0RBIV/267/2022-09-GAD dated 27.10.2022 forwarded the recommendations/selection list issued by the J&K Services Selection Board vide communication No. SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022 which also included selections for 379 (three hundred seventy nine) Class-IV posts pertaining to Department of Food, Civil Supplies & Consumer Affairs viz (01 Divisional Cadre, Jammu and 378 District Cadres) for appointment under the provisions of the J&K Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O 184 of 2020 dated 04.06.2020;

- C) The appointment of the above candidate shall further be subject to the following conditions:
 - a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.

b. Each appointee shall furnish an Undertaking in the shape of an

Affidavit as per Annexure-II to this Order.

c. The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agency.

d. The appointee shall be on probation for a period of two years.

e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.

f. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service.
