### Government Order No.95 -JK(FCS&CA) of 2023 Dated:- 26-07-2023

Whereas, the General Administration Department vide communication No. GAD/MTG0RB-IV/63/2021-09-GAD dated 18.10.2021 forwarded the recommendations/selection list issued by the J&K Services Selection Board vide communication No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 in respect of 490 (four hundred ninety) Class-IV posts pertaining to Department of Food, Civil Supplies & Consumer Affairs viz (47 Divisional Cadre, Jammu and 443 District Cadre, Kashmir) for appointment under the provisions of the J&K Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.0 184 of 2020 dated 04.06.2020;

2. AND WHEREAS, the General Administration Department had forwarded the selection list of the candidates to the respective Deputy Commissioners with the request to ensure the filling of their character verification rolls and forward the same to the Director General, CID, J&K, Srinagar for verification of Character and Antecedents of the candidates. The General Administration Department, subsequently, requested all the Deputy Commissioners to forward the verification report in respect of Character and Antecedents of all the selected candidates as received from the Criminal




Investigating Department (CID) J&K, directly to the appointing authorities so that the appointment orders of these candidates are issued;

- 3. **AND WHEREAS**, the validity of the select list expired on 17.10.2022 and the Department has received verification with regard to Character and Antecedents of the candidate namely Ms. Tahira Hafiez from the Criminal Investigation Department(CID), Srinagar through Deputy Commissioner Budgam vide communication number as mentioned in the reference, after the expiry of the validity of the select list;
- 4. **AND WHEREAS**, the matter her case also was taken up with the GAD for placing the same before the competent authority for re-validation of the select list of Class-IV (MTS), in her favour also, among others, in relaxation of sub-rule (5) of rule 14 of the J&K Civil Services (Decentralization) Rules, 2010, for the purpose of issuing appointment order;
- 5. **AND WHEREAS**, the General Administration Department vide U.0 No. GAD-CORD/29/2023-09 dated 24.07.2023 conveyed the approval of the competent authority to the Departmental proposal for extension of validity period of Select List in their favour also beyond its expiry date viz, 17.10.2022 upto 30.07.2023.

Consequent upon above, sanction is hereby accorded to the temporary appointment of 01 (One) candidate (forming Annexure-I to this order), figuring in the same selection list, as Class-IV (MTS), (District Cadre, Budgam) in the Department of Food, Civil Supplies & Consumer Affairs, Kashmir, in the Pay Level (SL-1) (Rs.14800-47100) with immediate effect.

The appointment of the candidate is subject to fulfillment of the following conditions:-

- A) The appointee(s) shall report to the Director, Department of Food, Civil Supplies & Consumer Affairs, Kashmir within a period of 21 days from the date of issuance of this order.
- B) The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:
  - i. Academic/Qualification Certificates.



- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Valid relevant Category Certificate, if any applicable.
- C) The appointment of the above candidates shall further be subject to the following conditions:
  - a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.

b. Each appointee shall furnish an Undertaking in the shape of an Affidavit as per Annexure-II to this Order.

c. The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agency.

d. The appointee shall be on probation for a period of two years.

- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a



- self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- g. The inter-se-seniority of the appointee in the J&K Food, Civil Supplies and Consumer Affairs (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- h. The appointment of the above appointee shall be cancelled abinitio, if it is found that they possess higher qualification than the prescribed one at any stage and he/she shall also be liable for criminal prosecution under law.
- i. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
- j. If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- k. If the candidate fails to join within a period of 21(twenty one) days from the date of issuance of this appointment order, he/she shall forego his/her right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department.

I. The Cadres allocated by the appointing authority/JKSSB shall not be changed under any circumstances by any Authority/Department.
