Consequent upon his re-instatement, Mr. Pranav Gandotra shall report to Assistant Director, FCS&CA, Kishtwar, with immediate effect, for further duties, who shall utilize his services against a non-sensitive post in the District, which shall not involve supply, storage & distribution work.

The period of his suspension shall be decided after conclusior of criminal proceedings and RDA pending against him.
