WHEREAS, Mr. Mohsin Muneer S/o Sh. Muneer Ahmad Yatoo R/o Hardpora, Nagam, Budgam was appointed in the Department of FCS&CA in (District Cadre) Budgam under EWS category as Multi-Tasking Staff (Class-IV) vide Government Order No. 139-JK(FCS&CA) of 2022 dated

AND WHEREAS, No. DFCS&CAK/Adm/PF/MTS/403 dated 02.08.2023 has informed that the Director Assistant Director, Budgam vide letter No. FCS&CA/bud/2023/1563-64 dated 03.07.2023 has sought genuineness of EWS certificate of Mohsin Muneer S/o Sh. Muneer Ahmad Yatoo R/o Hardpora, Nagam, Budgam issued by Tehsildar, Chadoora under No. Reader/Tchd/2020-21/391 dated 26.06.2020. The Tehsildar Chadoora in response vide letter No. 103/MM/23 dated 27.06.2023 reported that EWS certificate bearing No. Reader/Tchd/2020-21/391 dated 26.06.2020 issued in favour of Mohsin Muneer S/o Sh. Muneer Ahmad Yatoo R/o Hardpora, Nagam, Budgam has not been issued through his office and the certificate is not genuine. Accordingly cancellation of the said appointment has been recommended by the Director concerned;

AND WHEREAS, the appointment of the said candidate was subject to receipt of satisfactory report in respect of genuineness of qualification/Date of Birth/ Relevant category certificate from the concerned Authorities/Agencies and accordingly the genuineness of certificates was sought from the concerned issuing Authorities/Agencies by the Director,



AND WHEREAS, the appointment order of the said candidate inter-alia contained the following provisions for which the official has furnished an affidavit in this regard:-

- A. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/DoB/Reserved category certificates from the concerned issuing authorities is/are found fake/forged, his appointment as Multi Tasking Staff (Class-IV) in the Department of FCS&CA shall be deemed to have been cancelled ab-initio and legal action, as warranted under rules, shall be initiated against him.
- B. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory reports in respect of genuineness of Qualification/DoB /Relevant category Certificates is received from the concerned authorities/ agency.

AND WHEREAS, the matter was taken up with the Jammu and Kashmir, Services Selection Board vide this department letter No. FCS&CA/Food/ Misc/2023/7250406 dated 08.08.2023 with the request to kindly provide the copy of EWS certificate on the basis of which selection of the said candidate has Multi Tasking Staff (Class-IV) has been made;

AND WHEREAS, the JKSSB vide letter No. JKSSB-ADM/76/2023-03(E-7257992) dated 13.09.2023 has stated that Administration Department placed an Indent for filling up 8575 Class IV posts, pertaining to various departments under direct recruitment, with the Board. The selection for these posts was made by the Board in two phases. Among the selectees, Mr. Tawseef Ahmad Najar S/o Ghulam Rasool Najar R/o Drugmulla, Kupwara, figuring at serial No.2237, Roll No. 241424212919 and Mr. Mohsin Muneer S/o Muneer Ahmad Yatoo R/o Budgam at serial No. 403, Roll No. 221401340289, were recommended under EWS category in the Department of Food, Civil Supplies and Consumer Affairs, in District Cadres Kupwara & Budgam respectively. Both these candidates have submitted their application forms for these Class-IV Posts, advertised vide Notification No.01 of 2020 dated 20.06.2020 under EWS category, alongwith a self-declaration to the extent that all the particulars mentioned in their application form are true and correct, and if found incorrect, their selection shall be liable to be cancelled without any notice. Besides, the available record in the instant case indicates that the preliminary exercise to scrutinize documents/ certificates could not bring on record the error which has crept up in this case, as it was a huge selection, involving scrutiny of voluminous record.

AND WHEREAS, the matter was taken up with the General Administration Department which in turn vide U.O No. GAD-MTG0RBIV/182/2023 (7314866) dated 01.05.2024 has advised as under:-



"On consideration of the matter it has been observed that the candidate namely Mohsin Muneer S/o Muneer Ahmad Yatoo R/o Hardpora Nagam District Budgam, Class-IV/MTS, has failed to produce a valid EWS certificate after his appointment and he has also managed a fabricated genuineness report about the said EWS certificate. Accordingly, the Department is advised to cancel his appointment as Class-IV/MTS in terms of Clause (i) of appointment order issued by the Department vide G.O 139-JK(FCS&CA) of 2022 dated 28.12.2022."


AND WHEREAS, the matter was also taken up with Department of Law, Justice and Parliamentary Affairs which in turn vide U.O No. LAW-Opn1/47/2024-10 dated 05.06.2024 (C.No. 7484042) has observed as under:-

1. Vide Government Order No.139-JK(FCS&CA) of 2022 dated 28.12.2022, Mr. Mohsin Muneer S/o Sh. Muneer Ahmad Yatoo R/o Hardpora, Nagam, Budgam had been appointed in the Department of Food, Civil Supplies and Consumer Affairs as Multi-Tasking Staff (Class-IV) in (District cadre) Budgam under EWS Category, however, the incumbent had produced Social Caste Certificate instead of EWS Certificate at the time of joining.

2. The department took the matter with J&K Services Selection Board vide letter dated 08.08.2023 with the request to favour the department with actual category of the said candidate produced by selection/appointment and also specially indicate the category of his appointment.

3. JKSSB vide communication No. JKSSB-ADM/76/2023-03(E-7257992) dated 13.09.2023 has conveyed that the General Administration Department placed an indent for filling up 8575 Class IV posts, portaining to various departments under direct recruitment with the Board. The selection for these posts was made by the Board in two phases. Among other selectees, Mr. Tawseef Ahmad Najar S/o Ghulam Rasool Najar R/o Drugmulla, Kupwara, figuring at serial No. 2237, Roll No. 241414212919 and Mr. Mohsin Muneer S/o Muneer Ahmad Yatoo R/o Budgam at S.No. 403, Roll No. 221401340289, were supplies and Consumer Affairs, in district cadres of Kupwara and Budgam respectively.

4. Both these candidates have submitted their application forms for these Class-IV posts, advertised vide Notification No. 01 of 2020 dated 26.06.2020 under EWS category, alongwith a self-declaration to the extent that all the particulars mentioned in their application form are true and correct, and if found incorrect, their selection shall be liable to be cancelled without any notice. Besides, the available record in the



instant case indicates that the preliminary exercise to scrutinize documents/certificates could not bring on record the error which has crept up in this case, as it was a huge selection, involving scrutiny of voluminous record.

5. In light of the above, the department has proposed that the appointment namely Mohsin Muneer S/o Muneer Ahmad Yatoo R/o Hardpora Nagam District Budgam, Class-IV/Multi-Tasking Staff made vide Government Order No. 139-JK(FCS&CA) of 2022 dated possess the required void ab-initio as the incumbent did not secured the appointment. The candidate has lacked the basic eligibility as such his appointment is null and void.

6. In this regard, the law is clear on the point that appointment secured by misrepresentation and fraudulent ways and on the basis of non-not belong is void ab-initio and the same is liable to be cancelled forthwith without a notice. The candidate securing an appointment in Constitution or other statutory protections enshrined in different governing the field.

AND WHEREAS, it has been established that Mohsin Muneer S/o Muneer Ahmad Yatoo R/o Hardpora Nagam District Budgam has managed to secure his appointment in Government Service on the basis of fake/forged documents, which warrants initiation of cancellation of his appointment and initiation of Criminal proceedings against him.

NOW, THEREFORE, the appointment of Mr. Mohsin Muneer S/o Sh. Muneer Ahmad Yatoo R/o Hardpora, Nagam, Budgam as Multi-Tasking Staff in District Cadre (Budgam) under EWS category ordered vide Government Order No. 139-JK (FCS&CA) of 2022 dated 28.12.2022 is deemed to have been cancelled ab-initio. Salary, if any, paid to the appointee shall be recovered by the DDO concerned.
