Sanction is hereby accorded to the release of **Rs.21.35 lakhs** (Rupees Twenty One Lakh and Thirty Five Thousand Only) as Central share in favour of Director Finance Department of FCS&CA J&K i.e. Single Nodal Agency for Centrally Sponsored Scheme 4221- **Scheme for Modernization and Reforms through Technology in Public Distribution System (SMART-PDS)** as per annexure-"A" appended to this Government Order.

The Director Finance shall draw the funds and credit the same in the official Bank Account of Single Nodal Agency bearing A/C No.0110040570000101 maintained at J&K Bank, Moving Branch Civil Secretariat Jammu for further release/reimbursement, as admissible, to the implementing agencies through PFMS as per fixed component-wise limits.

However, the release and subsequent utilization of the funds is subject to the following terms and conditions:-

1. The funds shall be utilized strictly as per the guidelines and for the purpose for which it has been sanctioned/released.
2. The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities.
3. The amount shall be kept in SNA Account and drawn through PFMS.
4. The UC shall be furnished in respect of funds in the prescribed Performa.
5. The expenditure shall commensurate with the physical progress achieved.
6. All codal formalities in consonance with GFR shall be full filled before incurring the expenditure.
