The validity period for depositing of the cost and lifting of the foodgrains for the months of April 2012 will be 45 days and 50 days respectively from the date of issue of the letter. For the remaining months, the validity period for deposit of cost and lifting of foodgrains will be as per extant guidelines dated 18.07.2008.

The Rice allocated under Annapurna Scheme should be utilized only for the purpose for which the same have been allocated and not for any other purpose / scheme strictly in accordance with the guidelines of the scheme. The foodgrains under the scheme must be distributed through the Fair Price Shops.

It should be ensured that if there is any double counting error i.e. Annapurna beneficiary also issued the AAY card on individual basis, such duplication should be removed.

FCI will issue rice/ wheat to the nominees as per district wise sub allocation to be made by on pre-payment of the cost of foodgrains at BPL*price from its nearest godowns / depots.

Allocation for the balance period of the current year i.e. from October 2012 onwards under the Scheme will be considered only on receipt of proper Utilization Certificates in respect of foodgrains allocated for the year 2011-12.

You are requested to ensure that the allocated quantity of foodgrains (Rice) are lifted in full at BPL price from the FCI within stipulated time and also ensure timely submission of lifting / offtake statement including utilization certificate / QPRs regularly as per the prescribed format.
