The validity period for lifting of above quantities of foodgrains will be 50 days for each allocation month separately starting from 1st day of the month preceding the allocation month and ending the 20th day of the allocation month. The payment of cost of foodgrains shall be deposited with FCI latest by 15th of each allocation month.

The allocation quantities of foodgrains (Rice / Wheat) are to be lifted in full within the stipulated time ensuing that the ration amongst the districts is distributed / supplied as per the approved scale as per the Targeted Public Distribution System without any re-appropriation / diversification. Lifting / offtake statements as per prescribed format on monthly basis may be sent to the administrative department without fail besides furnishing Utilization Certificates as per prescribed format.
