Whereas, the Director, FCS&CA Jammu vide letter Nos.DFCS&CA/J/Acctts/2016-17/6821-22 dated:24-03-2017 and DFCS&CA/J/Acctts/2016-17/6871-72 dated:25-03-2017 requested to accord sanction alongwith advance drawal of Rs.23.00 lakhs for purchase of Computerized Electronic Weigh Bridge from Mechanical Engineering Department Jammu;

Whereas, vide Government Order No.65-FCS&CA of 2017 dated:29-03-2017, sanction alongwith advance drawal of Rs.23.00 lakhs was accorded for purchase/Installation of Electronic Weigh Bridge Machine at Food Store Nagrota;

Whereas, the Director, FCS&CA Jammu vide No.DFCS&CA/J/Acctts/2017-18/7240-43 dated:16-03-2018 requested for accord of Administrative Approval for installation of Weigh Bridge at Central Store, University Road Jammu in place of Food Store, Nagrota;

Whereas, this Department vide No.FCS&CA/Acctts/245/2018 dated:22-06-2018 requested the Director, FCS&CA Jammu to clarify as to why the Weigh Bridge was proposed to be shifted from Food Store, Nagrota to Central Store, University Road Jammu;

Whereas, the Director, FCS&CA Jammu vide No. DFCS&CA/J/Acctts/2018-19/2319.21 dated:06-08-2018 intimated that requisition for purchase/installation of new Weigh Bridge at Food Store, Nagrota was made to the Chief Engineer, Mechanical Division, Jammu, but due to delay in procurement/installation of Weigh Bridge, a Departmental Weigh Bridge installed at Warehouse Store was shifted to Food Store, Nagrota as per recommendations the Committee constituted for the purpose and the work for installation of Weigh Bridge at Food Store, Nagrota was issued to M/s Digitech Scales Bari Brahmana;

Whereas, this Department vide No.FCS&CA/Acctts/245/2018 dated:30-08-2018 sought further clarification/information regarding the reasons for seeking approval for shifting of Weigh Bridge from Nagrota Store to Central Store, University of Jammu and accordingly the reply to the observations was furnished vide communication No.DFCS&CAJ/Acctts/2018-19/3141-42 dated:11-09-2018 wherein it has been stated that the Weigh Bridge installed by the Food Corporation of India Nagrota Store was dismantled by the Corporation and accordingly requisition for sanction of new Weigh Bridge at Nagrota Store was projected. However, the procurement/installation of New Weigh Bridge at Nagrota Store by Mechanical Engineering Department was a time consuming process and working of Food Store Nagrota was suffering and accordingly the Weigh Bridge installed at New Store, Warehouse was shifted to New Store, Nagrota for smooth operations;

Whereas, vide this Department letter No.FCS&CA/Acctts/245/2018 dated:18-12-2018 Director, FCS&CA Jammu was requested to submit the estimates for supply/installation of Weigh Bridge at Central Store University Road Jammu and accordingly Director, FCS&CA Jammu vide No.DFCS&CA/J/Acctts/2018-19/4500-01 dated:18-12-2018 submitted the vetted estimates of Weigh Bridge amounting to Rs.23.80 lakh;

Whereas, the proposal of the Director, FCS&CA, Jammu to install an Electronic Weigh Bridge at Central Store University Road, Jammu was examined in the Administrative Department in view of the aforementioned circumstances and it was felt that installation of the Weigh Bridge at the proposed location is imperative for the Department.

Now, therefore, in exercise of powers vested under Chapter 4.9.1 of the J&K Book of Financial Powers, sanction is hereby accorded to the installation of Weigh Bridge at Central Store, University Road, Jammu in place of Food Store, Nagrota (Previously sanctioned vide aforementioned Government Order), for an amount of upto Rs.23.00 lakhs.
