

Subject:- Implementation of Ho'ble High Court Judgement dated 24.12.2011 passed in SWP No.1570/2004, titled Satish Kumar Sharma V/s. State & others

- 1/. Whereas, Sh. Satish Kumar Sharma Assistant Controller, (Retired) was initially appointed in Legal Metrology Department (Weights and Measures) as Manual Assistant G-II and joined his service on 02.09.2980.
- 2/. Whereas, Sh. Satish Kumar Sharma was adjusted as Inspector vide order No.WM/set/1716-20/1983 dated 08.03.1983 against direct quota post, in his own pay and grade.
- 3/. Whereas, Sh. Satish Kumar Sharma was confirmed as Inspector vide order No.51 of 1998 dated 10.11.1998 on the recommendation/clearance by the Departmental Promotion Committee.
- 4/. Whereas, Sh.Satish Kumar Sharma was further adjusted as Assistant Controller, vide order No.26 of 2002 dated 24.01.2002 and declared confirmed as per initial constitution issued vide Govt. order No.188 of CAPD of 2005 dated 10.10.2005.
- 5/. Whereas, the officer retired as Assistant Controller, LM Department Rajouri on 31.03.2011.
- 6/. Whereas, the Satish Kumar Sharma pleaded to get promotion as Inspector w.e.f. 1990, when he was eligible, being post graduate and as per Recruitment Rules of Weights and Measures Department (Subordinate services) 1962 & 1978 respectively where minimum qualification for the post of Inspector was graduate both for direct/promotion quota which remained in force till 1999.
- 7/. Whereas, as stated by Sh. Satish Kumar Sharma some matriculate/under graduate incumbents were promoted earlier to him with grade benefit against direct quota posts.

- 8/. Whereas, the officers filed SWP No.1570/04 titled Satish Kumar Sharma V/s. State and others and the Hon'ble Court passed the judgement dated 24.12.2011 and directed for compliance and implementation of the said judgement.
- 9/. Whereas, Sh. Satish Kumar Sharma was afforded an opportunity of being heard in person vide this office letter dt.06.09.2012 on 15.10.2012 alongwith supporting documents so that his case can be considered as per directions of Hon'ble Court.
- 10/. Whereas, the petitioner was heard in person and on the basis of his arguments the DPC was fixed and was held on 11.12.2012.
- 11/. Whereas, threadbare discussions were held in light of Court Judgement and it was pointed out that some juniors though Matriculate/Undergraduates were given grade benefits against direct quota posts.
- 12/. Whereas, it was also established that some Assistant Contollers of Jammu Division have retired w.e.f.1992 to 1996.

Now therefore, having regard to the above observations and re-examination of the material facts of the case, sanction is hereby accorded to the release of grade of the post of Inspector, Legl Metrology Department (Rs.1760-3200) pre-revised in favour of Sh. Satish Kumar Sharma, to bring him at par with his juniors who were allowed grade benefit vide order issued under endorsement No.WM/C-Esstt/28/2258-70/93 dt.23.04.1993 for pensionary benefits only.
