Subject: Write off an amount of Rs987398.20 on account of cost of deteriorated foodgarins of Kenalwan Godown in favour of Sh. Mohammad Ashraf Shiekh, the then Storekeeper Kenelwan Godown.

Whereas, vide letter No: CAPD/AD-Ang/5467-99 dated 16-01-2007 and vide No:CAPD/AD-Ang/5501 dated 18-01-2007, all the supervisors were directed to dispatch deteriorated foodgrains lying in their respective circles for back load to necessary dumping in Kenalwan Godown for its disposal by the committee.

Whereas, vide Assistant Director, CA&PD Anantnag's letter No: CAPD/AD-Ang/01 dated 4-4-2009, certified that following quantity of deteriorated foodgrains were lying in the Kenelwan godowns:-

Rice IR8 : 538.57 Qtls
Atta :490.61 Qtls
Wheat bran :75.05 Qtls
Empty Gunny Bags :2549 Nos.

Whereas vide letter No: 214-16 dated 27/12/2008, Dy Director CAPD (South Kashmir) has requested Public Analyst for examination of the deteriorated stocks, the Public Analyst vide letter No; PFAK/inf/200 and letter No PFAK/inf/198 dated 10-01-2009 had intimated that the stocks were not fit for human / live stock consumption, besides the Prof. and HOD of Div. of Animal Nutrition SKUAST vide his letter No: AU/FVS/ANN/09/312 dated 24-10-2009 has stated that "on the basis of physical examination, the sample of wheat bran received is not fit for feeding to live stock including poultry.

Whereas vide letter No: DCAPDK/Adm/GS-495/CG/1392 dated 02-01-2010, the Director CAPD Kashmir had recommended for necessary orders for its disposal/ destruction in presence of the District Level Committee as the stocks were declared not fit for human/Livestock consumption.

Whereas vide order No; 127-CAPD of 2010 dated 10-09-2010 committee of following CAPD officers was constituted for inspection of the deteriorated stocks lying in the Khanabal and Kanelwan Godowns:-

- Financial Advisor /CAO,CAPD, Department.
- Dy. Director (Supplies) CAPD Department, Kashmir.
- Dy. Director (South) CAPD department, Kashmir.

Whereas the Committee furnished its report dated 26/12/2010 with the recommendation that the deteriorated stocks may be destroyed as soon as possible after proper weightment in order to prevent any sort of epidemic and to make space of 5000Qtls available for storage.

Whereas vide Government Order No: 44-CAPD of 2013 dated 10-07-2013, on the recommendation of the Committee sanction was accorded to destruction/disposal of the deteriorated stocks lying in Khanabal and Kanelwan godowns Anantnag and subsequently the same were destroyed on 30.12.2013 at Kanelwan Srigufwara in presence of Committee members constituted vide aforesaid Government Order as per the details contained in the minutes of the meeting bearing No: 2784-86 dated 16-01-2014 besides the Director CA&PD Kashmir shall process the case of write off the value of the destroyed stocks strictly in accordance with the rules and the instruction issued by the Finance Department from time to time.

Whereas the Chief Accounts Officer, CAPD Kashmir vide Letter No: DCAPDK/Acctts/TA/609-611 dated 27-03-2014 had intimated that the book value of the destroyed/Disposed stocks lying in Kanelwan godowns amounts to Rs987398.20(Rupees Nine Lacs Eighty Seven Thousand Three Hundred Ninety Eight and Twenty paisa)only and is provisionally debited to Shri Mohammad Ashraf Shiek R.No:2818.

Therefore in view of the above facts and as recommended by Director CA&PD department Kashmir vide his No: DCAPDK/Adm/GS-495/Antg/229 dated 11.07.2014, sanction is hereby accorded to write off an amount of Rs 987398.20 only (Rupees Nine Lacs Eighty Seven Thousand Three Hundred Ninety Eight and Twenty Paisa) only in favour of Shri Mohammad Ashraf

Shiekh (retired) Storekeeper R.No:2818, on account of book value of the deteriorated / Disposed off of the stocks lying in Kanelwan Godown Anantnag, Kashmir.
