
Subject:- Winding up of Jammu and Kashmir District Consumer Forums constituted under Jammu and Kashmir Consumer Protection Act, 1987.

Government Order No: 103-FCS&CA of 2019
Dated: 24 -10-2019

Consequent upon repeal of the Jammu and Kashmir Consumer Protection Act, 1987 by the Jammu and Kashmir Reorganization Act, 2019, sanction is hereby accorded to the winding up of Jammu and Kashmir District Consumer Forums with effect from 31.10.2019 i.e the appointed date for formation of Union Territory of Jammu and Kashmir and Union Territory of Ladakh.

It is further ordered that:-

- i) The President/Member(s) of the Jammu and Kashmir District Consumer Forums shall cease to hold office w.e.f. 31.10.2019.
- ii) All the staff posted in the Jammu and Kashmir District Consumer Forums shall report to the Administrative Department by 30.10.2019.
- iii) The vehicles allotted to or purchased for the Jammu and Kashmir District Consumer Forums from time to time, if any shall be handed over to the Director, State Motor Garages Department.
- iv) The building(s) housing the Jammu and Kashmir District Consumer Forums, if any along with furniture and electronic gadgets shall be taken over by the concerned Assistant Directors of Department of Food, Civil Supplies & Consumer Affairs against proper receipt.
