- a) each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID J&K, whom a reference shall be made by the CAPD Department, the candidate shall have no right to claim his/her appointment as Assistant Controller and his/her appointment as such shall be deemed to have been cancelled ab-initio.
- b) Verification of the qualification Certificate/reserved category certificates (wherever applicable) from the concerned issuing authorities.

Salary of these appointees shall not be drawn and disbursed to them unless positive/satisfactory report in respect of (a) and (b) above is received.

The appointees shall be on probation for a period of two years. Their inter-se-seniority shall be notified separately.
