Subject:- Suspension of Shri Reyaz Ahmad Malik, the then TSO(Khrew Circle, Pulwama-reinstate thereof.

GOVERNMENT ORDER NO:- 14 -CAPD OF 2015 D A T E D:- 203 - 2015

Whereas, on the basis of complaint with regard to misappropriation of foodgrains, Mr. Reyaz Ahmad Malik TSO, Pulwama Godown, was placed under suspension vide Government order No. 36-CAPD of 2014 dated 03.06.2014;

Whereas, the Director, CAPD, Kashmir was asked to initiate an enquiry within a time frame of fortnight and on the basis of records whatever shortages is proved against the official be recovered from the concerned by way of attachment/sale of his property as arrears of land revenue by Deputy Commissioner concerned and if he fails to liquidate it within one week from the date of issuance of notice be served upon him immediately after establishing the outstanding.

Whereas, the Director, CAPD, Kashmir constituted a Committee of Officers with the following composition:-

- Dr. Gulzar Ahmad (Assistant Director(Adm) CAPD, Kashmir.
- (ii) Ms. Ruth Mary(I/C Assistant Director(South) CAPD, Kashmir.
- (iii) Shri Mohammad Rafiq Bhat(Examiner TA)

Whereas, the Committee submits its report and recommended that the action against the officials involved may be initiated as per Classification Control and Appeal Rules/CSR;

Whereas, Shri Reyaz Ahmad Malik(suspendee) questioned the recommendations of the Inquiry Committee on the grounds that he was not given any chance to defend;

Whereas, the request was examined and it was decided to constitute new Inquiry Committee headed by Special Secretary, CAPD with an officer from Accounts and Joint Director(Adm) CAPD, Kashmir as its members so that the principle of natural justice which has been agitated by the concerned official; Whereas, the said Committee constituted for the purpose submitted two report, one from Assistant Accounts Officer, CAPD and Joint Director, CAPD, Kashmir, another report has been submitted by the Special Secretary which was examined in the Department and it was observed that the report submitted by the Inquiry Officer(Special Secretary) is ambiguous. The Officer has not specifically given his explicit recommendations as a result of which nothing comes out of this inquiry. On the one hand, the Inquiry Officer is implicating the official and on the other hand he is maintaining that the said Official is not directly involved;

Whereas, the Inquiry Officer was accordingly requested to furnish his specific recommendations on the role of the concerned precisely;

Whereas, the Inquiry Officer vide his letter No:-CAPD/Estt/47/2014 dated 25.02.2015 reported that:-

"No embezzlement has taken place as reported by Chief Accounts Officer, as such there is no harm if the suspendee TSO Mr. Reyaz Ahmad Malik is reinstated; and

Now, therefore, in view of the above facts, Shri Reyaz Ahmed Malik the then TSO(Circle Khrew) Pulwama presently attached with Director, CAPD, Kashmir is hereby re-instated with immediate effect.
