**Subject : Rescinding of Transfers and Postings Orders issued by the Director,  
 FCS&CA, Jammu**

**Government Order No: - 15- FCS&CA of 2019**

**DATED :- 30 -01-2019**

Whereas, vide Government Order No. 11-FCS&CA of 2019 dated 16.01.2019, Pre-mature transfers and postings of Tehsil Supply Officers, Senior Assistants, Junior Assistants and Class-IV employees affected by Director, FCS&CA, Jammu vide Order Nos. 01-DFCS&CAJ of 2019 dated 01-01-2019 ; 03-DFCS&CAJ of 2019 dated 02-01-2019 ; 309-DFCS&CAJ of 2018 dated 21-12-2018 ; 315 -DFCS&CAJ of 2018 dated 26-12-2018 , No 307 -DFCS&CAJ of 2018 dated 20-12-2018 and 07-DFCS&CAJ of 2019 dated 04-01-2019, being in violation of the Transfer Policy notified vide Government Order No. 861/GAD of 2010 dated 28-07-2010 in pursuance to Cabinet Decision No. 156/12/2010 dated 27/07/2010 were rescinded;

Whereas, vide above mentioned Government order, besides seeking his explanation, the Director, FCS & CA Jammu was directed to furnish copies of all the orders issued by him after 15<sup>th</sup> December 2018 till date along with a copy of Order Register, as it was observed that despite mentioning copies having been endorsed to the administrative department, no such copies were ever received in the Department. He was also directed vide letter No. FCS&CA/Estt/03/2019 dated 18.01.2019 to provide the stay list of Head Assistants/Senior Assistants/ Storekeepers/Salesmen;

Whereas, from the perusal of transfer orders issued by him with reference to the stay list provided by him vide No. 315/G/187 dated 22.01.2019, it has been established that in addition to the transfer orders already rescinded, he has issued more orders vide Order No. 302-DFCS&CAJ of 2018 dated 15.12.2018, Order No. 305-DFCS&CAJ of 2018 dated 20.12.2018, Order No. 319-DFCS&CAJ of 2018 dated 28.12.2018, 320-DFCS&CAJ of 2018 dated 29.12.2018, Order No. 15-DFCS&CAJ of 2019 dated 12.01.2019 and Order No. 7(A)-DFCS&CAJ of 2019 dated 08.01.2019 affecting pre-mature transfers in violation of the transfer policy of the Govt. exceeding his authority;

Whereas, further, in his reply to the explanation, he has resorted to making false statement contrary to the factual position borne out by the records submitted by him only, which is an act of gross misconduct and unbecoming of a Government servant;

Now, therefore, for the aforesaid reasons Orders No. 302-DFCS&CAJ of 2018 dated 15.12.2018, 305-DFCS&CAJ of 2018 dated 20.12.2018, 319-DFCS&CAJ of 2018 dated 28.12.2018, 320-DFCS&CAJ of 2018 dated 29.12.2018, 15-DFCS&CAJ of 2019 dated 12.01.2019 and 7(A)-DFCS&CAJ of 2019 dated 08.01.2019, whereunder the Director FCS & CA Jammu has affected premature transfers in violation of the transfer policy, the same are hereby rescinded.
