Whereas, the contract to M/s AGT Pvt. Ltd for supply of PDS sugar to the State for the year 2018-19 expired in June, 2018;

Whereas, Director, FCS&CA Kashmir (Member Secretary, SLPC) floated e-tender vide No.07-FCS&CA-K of 2018 dated:16-04-2018 for supply of sugar to the state for a period of 6 months;

Whereas, in response to Director, FCS&CA Kashmir's e-tender notice referred to above, the following firms participated in the tendering process and offered the rates shown against each:

Whereas, M/s Sana Enterprises was found to be lowest bidder offering rates of Rs.40500 per MT;

Whereas, the rates, offered by the L1 supplier, were compared with the prevailing wholesale market rates and it was observed that the rates offered by the supplier are much higher than the wholesale rate;

Whereas, the State Level Purchase Committee recommended immediate re-tendering of sugar by the Department;

In view of the fact that the present market rates are lower than the rates offered by the supplier and after thorough examination of the issue, it was decided to cancel the tendering process for supply of sugar for distribution under PDS for the year 2018-19 in response to the Tender Notice No.07-FCS&CA-K of 2018 dated:16-04-2018 and to proceed afresh for re-tendering for supply of sugar by the Director, FCS&CA Kashmir (Member Secretary, SLPC).

Now, therefore, as per mandate under Clause 8 (C) of the Tender Notice, the tendering process for supply of sugar for distribution under PDS for the year 2018-19 in response to Tender Notice No.07-FCS&CA-K of 2018 dated:16-04-2018 is hereby cancelled and the Director, FCS&CA Kashmir (Member Secretary, SLPC) is directed to proceed ahead for re-tendering forthwith.


