**GOVERNMENT ORDER NO:- 158 -FCS&CA OF 2018**  
**D A T E D:- 21 - 06 -2018**

Whereas, the General Administration Department issued transfer policy vide Government Order No. 861/GAD of 2010 dated 28.07.2010 in compliance to Cabinet decision 156/12/2010 dated 27.07.2010 wherein, it was provided that in case of premature transfers/postings, the cases shall be referred to Administrative department for approval/decision;

Whereas, Department of FCS&CA vide Government Order 383-FCS&CA of 2017 dated 09.10.2017 had ordered for blanket ban on transfers/postings/deployment of officers/officials of FCS&CA/Legal Metrology Department. It was also ordered that no transfer/posting of any official shall be affected by the subordinate officers at any level;

Whereas, it has also been ordered that in case of Administrative exigency, the subordinate offices shall seek administrative approval for such transfers/deployment;

Whereas, despite the orders issued by the Government and instructions conveyed to subordinate offices from time to time, Director FCS&CA Jammu has issued transfer Order Nos.128 & 129-FCS&CAJ of 2018 dated 19.06.2018 in-defiance to the standing instructions in this regard;

Now, in view of the violation of Government Order No. 861/GAD of 2010 dated 28.07.2010 read with Government Order No. 383-FCS&CA of 2017 dated 09.10.2017, the transfer Order Nos. 128 & 129 -DFCS&CAJ of 2018 dated 19.06.2018 issued by Director FCS&CA Jammu, are hereby rescinded with immediate effect.
