Whereas, Director, FCS&CA Jammu and Director, FCS&CA Kashmir floated the e-Tender vide NIT Nos:- 02-FCS&CAJ of 2017 dated:- 02.08.2017 & 6-DFCS&CAK of 2017 dated:-22.02.2017 respectively.

Whereas, due to poor response received in respect of the Tenders, both the Directors proceeded for re-tendering vide NIT Nos:- 03-FCS&CAJ of 2017 dated:- 27.10.2017 in respect of Jammu division & 105-DFCS&CAK of 2017 dated:-02.05.2017 for Kashmir Division.

Whereas, Director FCS&CA Kashmir vide No. DFCS&CAK/Adm/GS-37/Genl/13/89 dated:-31.08.2017 intimated that despite repeated re-tenderings, each time only one Tenderer cast his tender and no other tenderer participated in the e-tendering process and sought necessary instructions with regard to consideration of single tender.

Whereas, a SLCC for grinding of wheat into whole meal atta has been constituted vide Govt. order 06-FCS&CA OF 2018 Dated:- 10.01.2018.

Whereas, the issue was examined in the Department and it was decided that the Tendering Process, if any under progress in the office of Director, FCS&CA Jammu/Kashmir, regarding grinding of wheat into whole meal atta be terminated ab-initio.

Now, therefore, sanction is hereby accorded to the termination of the Tendering process if any under progress in the office of Director FCS&CA Jammu/Kashmir in respect of grinding of wheat into whole meal atta for the year 2017-18, which shall henceforth be within the domain of the State Level Contract Committee constituted vide Govt. Order No. 06-FCS&CA of 2018 Dated:- 10.01.2018
