Whereas in the past, a number of officials of the LMD were attached from their respective places, where they were substantively posted, to various other offices;

Whereas, the GAD vide Circular No. 22-GAD of 2018 dated 06.07.2018 instructed detachment and repatriation of all attached officials to their respective departments/organisation;

Whereas, in terms of the aforesaid circular all such officials were required to be detached and repatriated to their respective offices where they were substantively posted;

Whereas, the Controller Legal Metrology Department while complying with these instructions exceeded the brief and along with the detachments affected a number of transfers vide Order No. 63-LM of 2018 dated 18.07.2018, many of which were even pre-mature;

Whereas this action of the Controller Legal Metrology Department has created administrative chaos as in many cases more than one official have been posted against one vacancy;

Now, therefore, with a view set the things right and strictly comply with the GAD instructions enabling submission of a report to the GAD the Order No. 63-LM of 2018 dated 18.07.2018 issued by the Controller, Legal Metrology Department under endorsement No. LM/C-Estt/23/2017 dated 18.07.2018 is hereby rescinded. Transfer and posting order are being issued separately
