Subject: - Release of commission charges of Fair Price Shop dealers under NFSA.

**Government Order No. 196 -FCS&CA of 2016
D a t e d: - 07 - 12 - 2016**


In supersession of all previous orders on the subject sanction is hereby accorded to the:-

- (i) Payment of commission charges to Fair Price Shop dealers @ 25% of admissible commission of Rs. 143/- per quintal (state share) as per rule 6 (1 & 2) of Notification No. GSR636 (E) dated 17.08.2015 of Union Ministry of Consumer Affairs , Food and Public Distribution, Department of Food and Public Distribution to Fair Price Shop dealers under NFSA out of the revolving fund with immediate effect;
- (ii) payment of commission charges to FPS dealers out of revolving fund @ Rs. 143/- per quintal for foodgrains being distributed by them under MMSFES/Tide over with immediate effect;

The Payment of the commission shall be subject to the fulfillment of the following conditions :-

- a) The expenditure on account of commission charges out of revolving fund be incurred strictly as per the guidelines issued vide Govt. Order No.96-CAPD of 2016 dated 08/06/2016.
- b) Commission charges shall be paid against the quantum of foodgrains distributed by Fair Price Shop dealers under NFSA/Tide over/MMSFES and shall in no case exceed the quantity actually distributed/handled.
- c) The payment shall be made by Assistant Director only after obtaining authentication from the concerned CAO's of the Directorate of Food, Civil Supplies and Consumer Affairs Jammu/Kashmir.

The Department shall take up the issue of release of funds for clearing the previous liabilities on account of commission charges due to the Fair Price Shop dealers with effect from February, 2016 on account of



NFSA/Tide over and MMSFES w.e.f 01.07.2016 with Finance Department. The arrears shall be cleared as soon as funds will be received from the Finance Department.

The Directorate of FCS&CA, Jammu/Kashmir shall put in place food account for all transactions relating to distribution of foodgrains and other commodities and a monthly statement in this regard be furnished to the Administrative Department by or before 15th of every month.

This issue with the concurrence of the Finance Department conveyed vide U.O. No. FD-VII-15(71)4235-II dated 20.09.2016.


