Sanction is hereby accorded to the re-appropriation of Rs. 35.00 Lacs out of Rs. 70.00 Lacs released vide Government Order No. 63-CAPD of 2011 dated 24/08/2011 for Construction of Working Standard / Secondary Laboratories towards Land Acquisition.

Sanction is also accorded to the release of Rs.31.00 Lakhs as additionality for payment of balance cost of acquisition of land. Thus aggregating Rs. 66.00 Lacs (Rs. 35.00 Lacs by way of re-appropriation and Rs. 31.00 Lacs as additionality) available for Land Acquisition for Construction of Laboratories at Jammu under Annual Plan 2011-12 and its placement at the disposal of Controller Legal Metrology Department.

- a) The funds released shall be utilized strictly in accordance with Codal procedures / formalities.
- b) The funds released shall not be available for re-appropriation at any level.
- c) Progress achieved under the scheme both in terms of financial and physical parameters shall be communicated to the administrative department on monthly basis.
