Whereas, pursuant to the O.M No. GAD(Vig) 52-RDA/2013 dated: 13-11-2013 the Administrative Department vide Communication No. CAPD/Estt/91/2013 dated: 04-12-2013 has requested Director Consumer Affairs and Public Distribution Department, Jammu to initiate an enquiry against Sh. Manmohan Suri, the then TSO, Surankote and Sh. Mohammad Sadiq, the then Storekeeper, Surankote in terms of JK CCA Rules; and

Whereas, a regular Enquiry vide No. 19-DCAPDJ of 2014 dated:11-01-2014 has been initiated against the above named Officials in terms of JK CCA Rules, by Director Consumer Affairs and Public Distribution Department Jammu by appointing Assistant Director CAPD Poonch as enquiry Officer; and

Whereas, the Assistant Director CAPD Poonch (Enquiry Officer) vide his Nos.342/AD/CAPD/P-2013-14 Dated: 28-01-2014 and 342/AD/CAPD/P-2013-14 Dated: 28-01-2014 has submitted his report with the observation that the excess payment was inadvertently paid to the dealer at the rate of Rs. 7488/- instead of Rs. 748/- but the same has been recovered and deposited in the treasury on 22-12-2014, and after verification of records by the Assistant Director Poonch it has been

found that both the officials are not involved in any other irregularity and misappropriation; and

Now, therefore, in view of the above stated facts and circumstances, Mr. Manmohan Suri, the then TSO, Surankote and Sh. Mohammad Sadiq, the then Storekeeper, Surankote are hereby censured so that to remain careful and faithful in future, failing which the department will be constrained to initiate strict disciplinary action as warranted under law.


