The Committee so constituted is charged with the following mandate:-

- To check rate list of the wholesalers viz FRO, decanting point and distribution point and distribution stations of all the wholesalers and the authority competent to fix the rates alongwith the copy of approval granted by the competent authority;
- (b) Criteria followed in the fixation of rates from time to time and the designated authority to fix or enhance the rates;
- (c) Verification of monthly statements from Tehsil Supply Officers (TSOs) regarding monthly allocation to retailers;
- (d) Verification of the feedback statements furnished to the ADs by the concerned TSOs;
- The status of licences and their renewal and the particulars of the actual licencees and sub-letting of the licences;
- (f) Whether the bills are being issued to the retailers;



- (g) Whether the retailers are making the payment in the bank accounts of the wholesalers with full particulars. (Account Number/ICFS Code/Name of the Bank and transactions held during last six months);
- (h) Functioning of GPRS System;
- (i) PDS Colour coding of the tankers;
- (j) Details of Government payment of VAT/Income Tax/Income Tax Returns for the last three years indication profit;
- (k) Whether, the Kerosene Oil carrying tankers are running on Kerosene Oil only.

The Committee will furnish its report/findings to Administrative Department with in a period of fifteen (15) days.
