In continuation to Government Order No. 74- CAPD of 2016 dated 20-04-2016, Sanction is hereby accorded to:

1. Enhancement of maximum slab/upper-limit of 35 kgs under Mufti Mohammad Sayeed Food Entitlement Scheme (MMSFES) to 50 Kgs per month in snow bound/remote areas of Marwah, Warwan, Dacchan, Padder, Budhal, erstwhile Tehsil Karnah, Machail of District Kupwara, Gurez of District Bandipora, Leh and Kargil Districts within the ceiling of available foodgrains and budgetary resources under Mufti Mohammad Sayeed Food Entitlement Scheme.

2. Providing of foodgrains under MMSFES over and above NFSA scale to PHH and NPHH rationees of above mentioned snow bound/remote areas having family size of 01 soul to 09 souls subject to maximum of 50 kgs per family in the following manner with immediate effect:

The families having 10 souls and above shall only be entitled foodgrains as per NFSA scales.

The Sale rates of foodgrains shall remain the same as notified vide Government Order No. 74-CAPD of 2016 dated 20-04-2016.

The requirement of additional foodgrains on this account shall be met out of overall savings under the MMSFES and utilized for distribution among the bonafide beneficiaries of above mentioned snow bound/remote areas only.
