- 07. The further release of funds may be subject to the submission of adjustment accounts duly verified by Accountant General, J&K and the utilization certificates by the Directors Department of FCS&CA Jammu/Kashmir.
- 08. The Director, Department of FCS & CA Jammu/Kashmir shall submit the detailed Accounts on the subject matter in accordance with the rules in vogue.
