  - 5. The further release of funds may be subject to the submission of adjustment accounts duly verified by Accountant General, J&K and the utilization certificates by the Director, Department of FCS & CA Jammu to Administrative Department of FCS & CA J&K.
  - 6. The Director, Department of FCS & CA Jammu shall submit the detailed Accounts on the subject matter in accordance with the rules in vogue.
  - 7. The funds shall be utilized for the specified purpose only after strictly observing all codal formalities required under rules and instructions issued by the authorities from time to time.
