Subject:- Providing of additional ration to BPL category, Priority Households and NPHH families over and above the NFSA scale.


It is hereby ordered that:-

- i. Additional provision of foodgrains at 2Kg/head, over and above the NFSA entitlement of 5 Kg/head, for all 17.85 lakh individuals of BPL(PHH) category upto a family size of six. The additional 2 Kg per head shall be priced at the highly subsidized rate of Rs. 12/- per Kg of rice and Rs 10/- per Kg of Wheat. No change in respect of the AAY category which will remain fully protected and covered.
- ii. Additional provision of foodgrains at 2 Kg per head over and above the NFSA entitlement of 5 Kg/head for all 42.51 lakh individuals of PHH category. The additional 2 Kg per head shall be priced on subsidized rates which works out to Rs 20/- per Kg of rice and Rs. 13/- per Kg of Wheat.
- iii. Additional provision of foodgrains of 2 Kg per head over and above 5 Kg per head in respect of 45 lakh individuals under the Non Priority Household(NPHH) category on a "no profit" basis, the rates of which work out to Rs 25/- per Kg of rice and Rs 18/- per Kg of Wheat.

Finance Department shall provide additional resources to the extent of Rs 105.00 crores to Consumer Affairs and Public Distribution Department to implement the enhanced scale over and above the NFSA entitlement.

- iv. Finance Department shall also provide an annual Trading account facility of Rs 630 crore for upfront procurement of additional foodgrains for immediate and efficient implementation of the above decisions.

- v. **Consumer Affairs and Public Distribution Department will formulate a scheme so as to ensure that Atta is distributed in place of Wheat wherever required and obtain the approval of Competent Authority for the same.**

This shall come into force w.e.f 01.04.2016.
