Whereas, the employees of various Consumer Forums have approached to the Hon'ble High Court for seeking the directions through the medium of SWP No.2056/2010 titled Satish Kour Vs state and others and SWP No.2488/2011 titled Nazir Ahmed Nazir Vs State and Others for framing of recruitment rules for granting the promotion avenues; and

Whereas, The Hon'ble High Court by virtue of Orders dated:17-09-2013 and 25-11-2013 directed the respondents to prepare/formulate the recruitment rules providing for adequate promotion avenues at all levels and in the event there are recruitment rules in force, accord consideration to the petitioner's claim for promotions in accordance with such rules; and

Whereas, there are no recruitment rules of the cadre in force. The claim of the petitioners for promotion cannot be considered in absence of recruitment rules but process of framing of the recruitment rules of the services is under the active consideration of the department which is a time consuming process, as the same will be finalized in consultation with the Department of Law,

Whereas, pursuant to the Orders of the Hon'ble High Court, the case of the petitioners has been examined in this department and it was decided to adopt the Jammu and Kashmir Secretariat (Sub-ordinate) Services rules 1998 for the services of employees of Consumer Forums till the finalization of the recruitment rules of the respective services.

Now, therefore the method of recruitment and the conditions of the service prescribed under the Jammu and Kashmir Secretariat (Sub-ordinate) Services rules 1998 shall be adopted for the services of employees of Consumer Forums till the finalization of the service rules of the consumer forums.
