- (ii) Distribution of the allocated foodgrains shall be made on pro rata basis to the eligible BPL families in monthly installments from August 2014- March 2015 during the financial year 2014-15 as mentioned in the aforementioned referred letter.
- (iii) The additional rice will be lifted in eight equal monthly installments for distribution during August 2014 to March 2015. The allocation for distribution in the month of August should be lifted by 31.7.2014 positively. Similarly for distribution in subsequent months it should be lifted by the end of previous month. No extension in the validity period for lifting will be allowed.
- (iv) The cost Price of the said allocation shall be met out of the funds already released. The requirement of fund may be reflected in the Revised Estimates 2014-15. However the handling Charges shall be restricted at Rs940= per MT in respect of Wheat and Rs590=00 per MT in respect of Rice as the Finance Department has advised to rationalize the handling Charges. The amount so incurred on the procurement of the allocation shall be reflected in the Revised Estimates 2014-15.
