**Government Order No. 49 - CAPD of 2014  
Dated: 18 .07.2014**

Whereas, the Deputy Commissioner, Reasi along with Sub Divisional Magistrate, Mahore and Assistant Commissioner (Development) Reasi inspected the office of Tehsil Supply Officer, Mahore on 26.6.2014 and found a lot of discrepancies in the records;

Whereas, the Deputy Commissioner, Reasi vide his Communication No. PS/DC/Rsi/14/1029-31 dated 29.6.2014 has intimated that the concerned TSO has maintained only the record of 2300 Ration Card copies, whereas, the Assistant Director, CA&PD, Reasi in 2012 had issued 4000 Ration Card copies to TSO Mahore thereby meaning that around 1700 Ration Card copies have been issued without any record;

Whereas, the Deputy Commissioner, Reasi has also intimated that public of the area have ventilated serious concern over the non-availability of ration in the area;

Now therefore, pending inquiry, Mr. Mohammad Yaqoub, TSO Mahore, is placed under suspension with immediate effect and attached with the Directorate of CA&PD, Jammu.

For the purpose of inquiry, Director CA&PD, Jammu shall constitute a team, conduct an inquiry into the matter and furnish a report to this office within a period of one week.


