Terms of Reference of the Committee shall be as under:-

- i. To find out the Allocation of K. Oil (SKO) to Rajouri District by the Directorate of FCS&CA Jammu and its further allocation to Tehsils of Rajouri District specifically to Tehsil Kalakote, during the reference period.
- ii. Bifurcate the total allocation of K. Oil to Tehsil Kalakote TSO-wise, during the reference period.
- iii. Dealer-wise quota of K.Oil (SKO) released by the TSOs of Kalakote Tehsil, who held the office during the period in question (TSO-wise), to the dealers of Triath area.
- iv. Dealer-wise receipt and distribution of K.Oil (SKO) made by the dealers to the consumers in Triath area of Kalakote.
- v. Whether the distribution shown done by the dealers is supported by UCs.

The Committee should also suggest corrective measures to be taken by the FCS&CA Department to streamline the distribution of PDS quota K.Oil among the eligible consumers.

The committee shall scrutinize all the relevant records for the period under reference to establish any misappropriation or otherwise of SKO and submit its report

within fifteen days time.
