In pursuance to Finance Department's authorization conveyed vide U.O No.FD/Res/CSS/2017-18/NFSA/280/692 dated:01-02-2018, sanction is hereby accorded to the release of funds to the tune of Rs.714.55 lakh (Rupees Seven hundred fourteen lakh fifty five thousand only) in favour of Director, FCS&CA Kashmir for further release to Assistant Directors (**as per enclosed annexure**) on account of Fair Price Shops Dealer's margin under the CSS "National Food Security Act, 2013" subject to the following conditions:

1. The Funds shall be utilized for execution of the scheme strictly as per originally approved components and accordingly to Government of India's prescribed guidelines.
2. The Director shall furnish Utilization Certificates alongwith disbursement statement against the approved projections as early as possible and definitely well before 31-03-2018 to the Adm. Department for further submission to the Government of India.
3. The line Department concerned is advised to adhere strictly to the guidelines under the relevance scheme and the expenditure on this account shall be incurred subject to reconciliation with respect to expenditure already met out of State share or any other source after fulfillment of all codal formalities issued from time to time.




