**Subject:-** Cancellation of appointment of Sh. Rajesh Kumar S/o Sh. Nagar Mal R/o Village Chak Jaralan Tehsil Bishnah Distt. Jammu as Assistant Controller, Legal Metrology Department.

Whereas Sh. Rajesh Kumar S/o Nagar Mal R/o Village Chak Jaralan Tehsil Bishnah Distt. Jammu was selected against the post of Assistant Controller Legal Metrology Department under (SC) Category by the Public Service Commission.

Whereas, on the basis of selection by the Public Service Commission, he was appointed as Assistant Controller, Legal Metrology Department Distt. Kulgam against available vacancy vide Government Order 28-CAPD of 2012 dated 20-03-2012.

Whereas, he was asked to produce requisite documents (original) before Joint Controller Legal Metrology Department Kashmir at the time of joining.

Whereas, he did not join at his place of posting as intimated by the Joint Controller Legal Metrology Department Kashmir vide his letter dated 7-5-2012.

Whereas, a notice was served upon him by this Department vide Letter No. CAPD/LM/10/2009 dated 15-5-2012 to join within (7) days failing which it will be presumed that he is not interested to join as Assistant Controller Kulgam.

Whereas, he again did not join despite issuance of the above notice.

Whereas, a final notice was served upon him vide this Department Letter No.CAPD/LM/10/2009 dated 6-7-2012 to join within 7 days, which also stands published in "Daily Excelsior" News paper Jammu on 18-7-2012 and "Greater Jammu" News Paper on 18-7-2012.

Whereas, despite wide publicity of the notice for joining he has failed to join as Assistant Controller Legal Metrology Department Distt. Kulgam, till date.

Now, therefore, having regard to the aforementioned circumstances the appointment of Sh. Rajesh Kumar S/o Nagar Mal R/o Village Chak Jaralan Tehsil Bishnah Distt. Jammu as Assistant Controller, Legal Metrology Department Distt. Kulgam made vide Government Order 28-CAPD of 2012 dated 20-3-2012 is hereby cancelled with immediate effect.




