Subject:- Implementation of Government Order No.39-FCS&CA of 2017 dated 20.02.2017 issued by FCS&CA Department- Guidelines thereof.

Government Order No. 62 -FCS&CA of 2017
D a t e d: - 27 - 03 - 2017

To ensure implementation of Government order No.39-FCS&CA of 2017 dated 20-02-2017 issued by FCS&CA Department regarding implementation of Imposition of restrictions on injudicious use of Essential Commodities in social/Government/private functions in letter and spirit and to check/control the violations of same at ground/field level, it is hereby ordered as under:-

- I. The Deputy Commissioners of respective Districts and the Municipal Commissioners of Srinagar/Jammu are hereby designated as Nodal officers for implementation of the various provisions of the Government Order No.39-FCS&CA of 2017 dated 20-02-2017 within their areas of jurisdiction. The Sub-Divisional Magistrates and Tehsildars of respective Sub-Divisions/Tehsils shall be responsible for implementation of the Government Order within their area of jurisdiction.

They will be responsible for monitoring, controlling and coordinating the functioning of marriage Halls/Banquet halls/JhanjGhar (so far as it relates to the provisions of instant Govt. Order) within their areas of jurisdictions. They shall also keep in view the orders of Hon'ble Supreme Court of India dated 18.07.2005 in the case titled, "implementation of the Laws for restricting use of loud speakers and high volume producing sound systems" issued in (SLP(C) No.2/851/2003), Notification dated 06.09.2006 issued by Government of India, Ministry of Commerce & Industry, Department of Industrial Policy and promotion regarding sound emitting crackers and other relevant Acts/Rules/Government Orders, issued by the Union/State Government, from time to time in this regard. They shall also involve religious heads of various communities and senior citizens in proper implementation of the provisions of the order

- II. The Deputy Commissioner of the respective Districts shall constitute District Level Committees comprising of the following members :-
- i) Additional Deputy Commissioner.
 - ii) Assistant Director, FCS&CA Department.

- iii) Assistant Commissioner, Food Safety.
- iv) Assistant Controller, Legal Metrology Department.

The Committee shall regularly monitor the implementation of all the provisions of the instant Government Order in letter and spirit in all such functions being organized within their areas of jurisdiction and take necessary remedial/legal action against defaulters. The Committee shall submit monthly report to the Deputy Commissioners who will in turn submit a consolidated report to Administrative Department of FCS&CA accordingly.

- III. The Deputy Commissioners/ Municipal Commissioners/other designated Executive Magistrates shall take legal action as warranted under rules against the defaulters within their areas of jurisdiction particularly Section 188 of RPC and Section 133 of CrPC.
- IV. The District Level Consumer Councils (constituted vide SRO-262 dated 9th August 2016) shall also play active role to ensure implementation of the instant Government Order within their areas of jurisdiction and shall report violations if any, to the Deputy Commissioner concerned for further course of action.
- V. Two Divisional Level Committees one each for Kashmir/Jammu comprising of following members are also constituted who will monitor/regulate the implementation of the instant Government Order at the divisional level:-
 - Director, FCS&CA Department Kashmir/Jammu.
 - Regional Director, Pollution Control Board, Kashmir/Jammu.
 - Joint Controller, Legal Metrology Department, Kashmir/Jammu.
 - Assistant Commissioner, Food safety and standard organization.
