Subject to the condition that:

- All financial rules/orders and instructions issued by the Govt. from time to time shall be observed while incurring expenditure against the allocated amounts.
- Administrative Approval/Technical sanction wherever required should be obtained before the expenditure is incurred.
- It shall be ensured that the expenditure is supported by an 'Act of sanction' by the Authority Competent to sanction such expenditure.
- The expenditure should be incurred uniformly throughout the year to avoid rush of expenditure in any one or more months. The Drawing and Disbursing Officer will take steps to curtail expenditure under OE, TE, POL, Telephone and other Service Heads.
- It shall also be ensured that the expenditure under various Budget Heads is kept within the sanctioned allocations and incurred only with the prior approval of higher authorities, where so prescribed.
- The monthly expenditure/drawal statements shall be submitted to the relevant quarters regularly on monthly basis by or before 10th of the succeeding month.
