Sanction is hereby accorded to:

- a) Withdrawal of the Government Order No.57-FCS&CA of 2018 dated:23-02-2018 with immediate effect, and
- b) Release of funds to the tune of Rs.2044.58 lakh (Rupees Two thousand forty four lakh fifty eight thousand only) in favour of Director, FCS&CA Jammu for further release to Assistant Directors, FCS&CA Department (**as per enclosed annexure**) on account of Fair Price Shops Dealer's margin under the CSS "National Food Security Act, 2013" subject to the following conditions:
 - i. **The release includes the commission charges for the months of 01/2017, 02/2017 and 03/2017 and as such, the commission payable to the FPS Dealers for the foodgrains actually distributed by them from 01-01-2017 to 31-03-2017 may be deducted from such claim for the 4th Quarter of Financial Year 2016-17 to be submitted by the Director, FCS&CA, Jammu to the Adm. Department for further submission to Government of India.**
 - ii. The Funds shall be utilized for execution of the scheme strictly as per originally approved components and accordingly to Government of India's prescribed guidelines.
 - iii. The Director shall furnish Utilization Certificates alongwith disbursement statement against the approved projections as early as possible and definitely well before 31-03-2018 to the Adm. Department for further submission to the Government of India.
 - iv. The line Department concerned is advised to adhere strictly to the guidelines under the relevance scheme and the expenditure on this account shall be incurred subject to reconciliation with respect to expenditure already met out of State share or any other source after fulfillment of all codal formalities issued from time to time.
 - v. The Directorate may ensure to book the expenditure as per the following classification for proper accounting:


