The Advance Drawal of funds shall be subject to the following terms and conditions:

1. The funds shall be utilized strictly for the purpose and shall not be re-appropriated in any circumstance.
2. No diversion of funds shall be done and the expenditure shall be incurred within the budget allocation.
3. All the instructions issued by the competent authorities from time to time shall be strictly adhered to.
4. The progress achieved under the Scheme both in terms of Physical/ financial shall be communicated to the Administrative Department by 1st of each month.
5. The further release of funds may be subject to the submission of adjustment accounts duly verified by Accountant General, J&K and the utilization certificates by the Director, Department of FCS & CA Jammu to Administrative Department of FCS & CA J&K.
6. The Director, Department of FCS & CA Jammu shall submit the detailed Accounts on the subject matter in accordance with the rules in vogue.
7. The funds shall be utilized for the specified purpose only after strictly observing all codal formalities required under rules and instructions issued by the authorities from time to time.


