**Subject**: Allocation of PDS-SKO Quota for the month of September, 2019 of Financial Year 2019-20.

GOVERNMENT ORDER NO: D A T E D: 86 - FCS&CA of 2019 13 /09/ 2019

Sanction is hereby accorded to the Allocation of **3612 KLs (Three Thousand Six Hundred twelve Kilolitres only)** for Month of **September, 2019** to the Districts/ whole Sale Dealers of Jammu/Kashmir divisions of the State as per **Annexure "A", "B","C" and "D"** to this Government Order.

#### The allocation of PDS - SKO shall be subject to the following conditions:-

- 1. PDS-SKO is a regulated product and can be stored / handled by the licensed persons/agencies only. It is noticed that most of the Wholesale dealers have not renewed their licenses. This current month's allocation shall further be released /issued in Favour of Wholesale Dealers by the both the Directors only on the undertaking from the concerned whole sale dealers mentioning that he will get his license renewed in the month of September, 2019. Completion of Documentary formalities is the responsibility of wholesale dealer and in case he is not able to renew the license, his quota will be diverted to other Licensed SKO Dealers / as per decision of the Food, CS&CA Department and it will be binding upon him. The Directors shall submit a copy of the said undertaking to this Department in the format as obtained from the Wholesale Dealers.
- 2. The Directors shall obtain similar undertaking with regard to Retail Dealers from Assistant Directors of the concerned Districts.
- 3. The Directors shall ensure that the said quota is released in the first week of month.

4. The Directors shall ensure that the full quota of SKO for the month is utilized/lifted. It shall be their personal responsibility;

5. The Utilization Certificates shall be furnished by or before 5<sup>th</sup> of this month positively and the allocation for the next month be released only after authorization from administrative Department;

6. The Director of FCS&CA, Jammu/Kashmir may also send their compliance to Administrative Department through fax along with the certificate that there is no complaint of any malpractice against any whole sale dealer in the previous month, before making further district wise allocation;

- 7. The Quota of District should not be changed and the Directors may depute the SKO Wholesale Dealers to other Districts in case the quota of the District do not match with the Quota of the Wholesale Dealer;
- 8. The Director of FCS&CA Department, Jammu/Kashmir shall also ensure that the last month's district wise allocated quota to whole sale dealers has reached at the proper destination and the concerned Assistant Director had certified that the K.Oil had been properly distributed among the ration card holders in the district and there is no complaint against distribution of SKO;
- 9. The Director of FCS&CA Jammu/Kashmir will ensure that Assistant Director concerned collects the certificate from each PDS-SKO dealer issued by the PRI of the area before issuing the next month's quota.
- 10. The Director of FCS&CA Jammu/Kashmir will furnish the dealer-wise/company-wise, upliftment /distribution achievement by the end of month positively in any way;
- 11. The Director, FCS&CA Jammu/Kashmir may strictly enforce the instructions issued vide this department's letter No. CAPD/Plan/SKO/01/2011-12 dated 6-12-2013 so far as allocation of PDS-SKO quota to Cooperative Kerosene dealers is concerned and not to associate the Deputy Registrars of Co-operative Department in the process. The Assistant Directors of FCS&CA Department shall allocate the quota of SKO to the Cooperatives Kerosene Dealers keeping in view the number of ration tickets attached to them;
- 12. The Director, FCS&CA Kashmir/Jammu shall obtain a certificate from Assistant Director that all the payments by retailers to the wholesale SKO dealers is made by Account payee cheque or NEFT transfers;
- 13. Further distribution shall be made after furnishing the certificate by the Director FCS&CA that the quota for the previous month has been fairly distributed in full and that there is no complaint;
