WHEREAS, Director, Food & Civil Supplies, Jammu/ Chairman, Provincial Level Contract Committee (PLCC) had floated a tender for hiring of transport for carriage of food-grains of the Department of FCS & CA in respect of Jammu Division *vide* e-NIT No.6-FCS&CA of 2018, dated 11.02.2019;

• WHEREAS, some complaints were received regarding the allotment process of the tender and rebate offered by the L1 bidder;

WHEREAS, the Competent Authority directed for constitution of a Committee to scrutinize the tendering process for hiring of transport for carriage of foodgrains and, accordingly, vide Government Order No.582-GAD of 2019, dated 14.05.2019, a Committee was constituted by the Government under the Chairmanship of Financial Commissioner, Finance Department;

WHEREAS, the aforesaid Committee under the chairmanship of Financial Commissioner, Finance Department, deliberated on the issues and concluded/recommended as follows:

"Keeping in view the gravity of the matter as brought out above with respect to issues under consideration, the Committee unanimously decided to recommend that the bid document needs revision to have consistency with the existing guidelines of procurement as per the codes and thus the tendering process initiated by the Director, FCS&CA, Jammu, needs to be cancelled and fresh tenders should be issued with tender document duly vetted by the Law Department afresh".

WHEREAS, the recommendations of the Committee were submitted to the General Administration Department (GAD) for approval of the Competent Authority;

WHEREAS, the GAD vide U.O.No.GAD(Adm)59/2019-IV, dated 18.07.2019, conveyed acceptance in respect of the recommendations of the aforesaid Committee as reproduced below:-

- i. The bid document needs revision to have consistency with the existing guidelines of procurement as per the codes and thus the tendering process initiated by the Director FCS&CA, Jammu, needs to be cancelled and fresh tenders should be issued.
- ii. The tender document be duly vetted by the Law Department afresh.
