Sir,

The <u>Allocation</u> of PDS- SKO Quota to Whole Sale Dealers/Districts of both the divisions of the State i.e Kashmir division (excluding Ladakh) and Jammu division has been fixed to the extent of **9440 Kls** for the month of December, 2016 as per <u>annexure "A", "B", "C" & "D"</u> respectively. The allocation of PDS - SKO shall be subject to the following conditions:

- 1. All the conditions laid down in SRO 285 dated 02.09.2016 of J&K Government relating to "Rationalization of Distribution of Kerosene Oil" shall be strictly adhered to while transporting and distributing SKO.
- 2. Both the Directors of FCS&CA, Jammu/Kashmir may also send their compliance to Administrative Department **through fax** along with the certificate that there is no complaint of any malpractice against any whole sale dealer in the previous month, before making further district wise allocation.
- 3. The Quota of District as per Annexures "C" & "D" should not be changed and the Directors may depute the SKO Wholesale Dealers to other Districts in case the quota of the District do not match with the Quota of the Wholesale Dealer.
- 4. The Directors of FCS&CA Department, Jammu/ Kashmir shall also ensure that the last month's district wise allocated quota to whole sale dealers has reached at the proper destination and the concerned Assistant Director had certified that the K.Oil had been properly distributed among the ration card holders in the district and there is no complaint against distribution of SKO.
- 5. The Director of FCS&CA Jammu/Kashmir will ensure that Assistant Director concerned collects the certificate from each PDS-SKO dealer issued by the PRI of the area before issuing the next month's quota.



- 6. The Director of FCS&CA Jammu/Kashmir will furnish the dealer-wise/company-wise, upliftment/distribution achievement by the end of this month positively in any way.
- 7. The Director, FCS&CA Jammu/Kashmir may strictly enforce the instructions issued vide this department's letter No. CAPD/Plan/SKO/01/2011-12 dated 6-12-2013 so far as allocation of PDS-SKO quota to Cooperative Kerosene dealers is concerned and not to associate the Deputy Registrars of Cooperative Department in the process. The Assistant Directors of FCS&CA Department shall allocate the quota of SKO to the Cooperatives Kerosene Dealers keeping in view the number of ration tickets attached to them.
- 8. Further distribution shall be made after furnishing the certificate by the Director FCS&CA that the quota for the previous month has been fairly distributed in full and that there is no complaint.
