- 3. The validity period for deposit of cost and lifting of the above revised allocation under NFSA for the month of February and March, 2016 will be 30 days from the date of issue of this letter. The validity period for rest of the months will be as per the existing instructions conveyed vide this Department's letter No.1-2/2007-BP.III dated 11.07.2014. Further, any quantity of foodgrains already lifted in excess of the above revised allocation will be adjusted against the allocation of subsequent months.
